CORNER OF THE SW 1/4 OF THE N.E. 1/4 OF SECTION 10 TWP. 4 N. R. 28 E.W.M; THENCE WEST ALONG THE CENTER LINE OF RIDGEWAY AVE.-320.0 FEET TO THE MONUMENT REPRESENTING THE CENTER OF SAID SECTION 10, THENCE CONTINUING ALONG THE CENTER LINE OF RIDGEWAY AVE.-1980.56 FEET TO THE INITIAL POINT OF THIS SURVEY AT WHICH POINT I PLACED A 2 INCH GALVANIZED IRON PIPE 3 FEET LONG, THE TOP OF WHICH IS 8 INCHES UNDER THE SURFACE OF THE GROUND AS PER SEC. 19-1304 OREGON CODE ANNOTATED; THENCE CONTINUING ALONG THE CENTER LINE OF RIDGEWAY AVE.-660.19 FEET; THENCE AT RIGHT ANGLE SOUTH- 659.70 FEET TO THE CENTER LINE OF HERMISTON AVE; THENCE AT RIGHT ANGLE EAST ALONG THE CENTER LINE OF HERMISTON AVE. 660.19 FEET; THENCE AT RIGHT ANGLE, NORTH- 659.70 FEET TO THE INITIAL POINT.

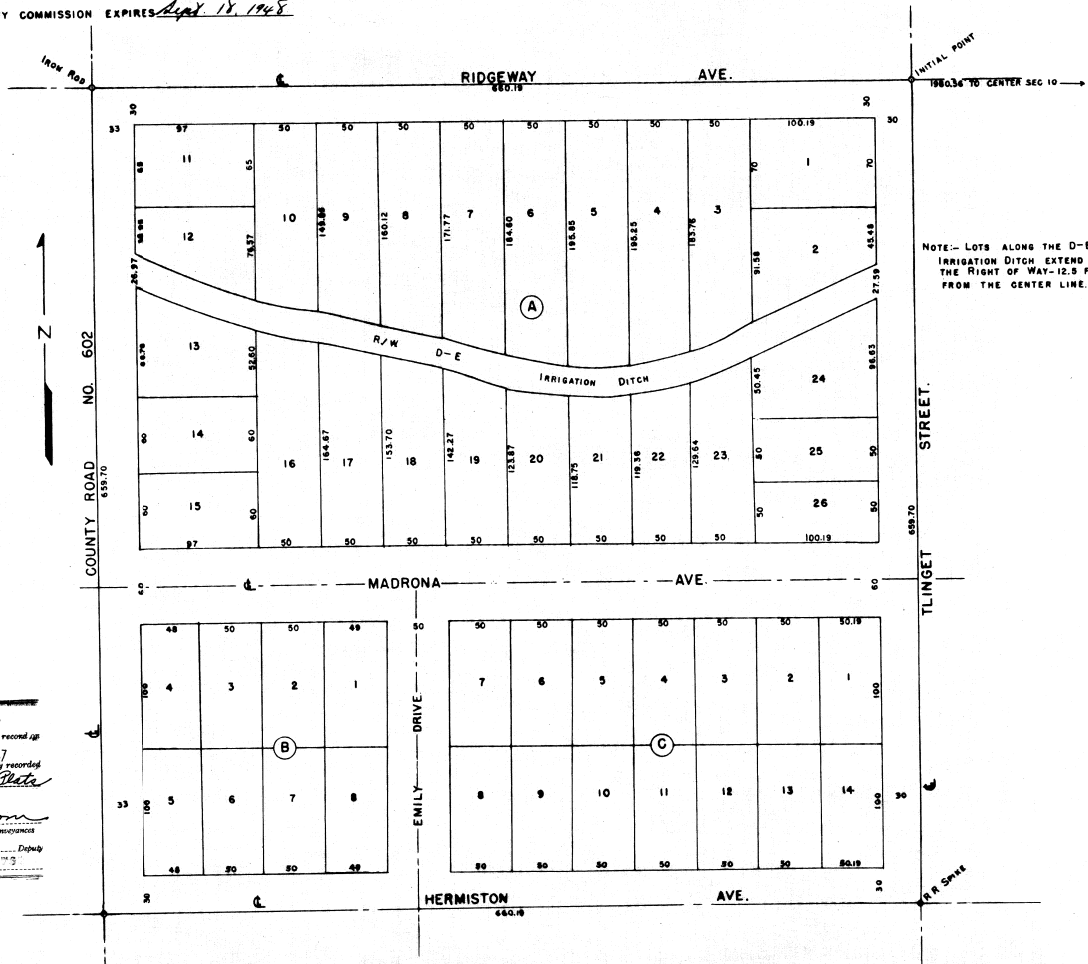
