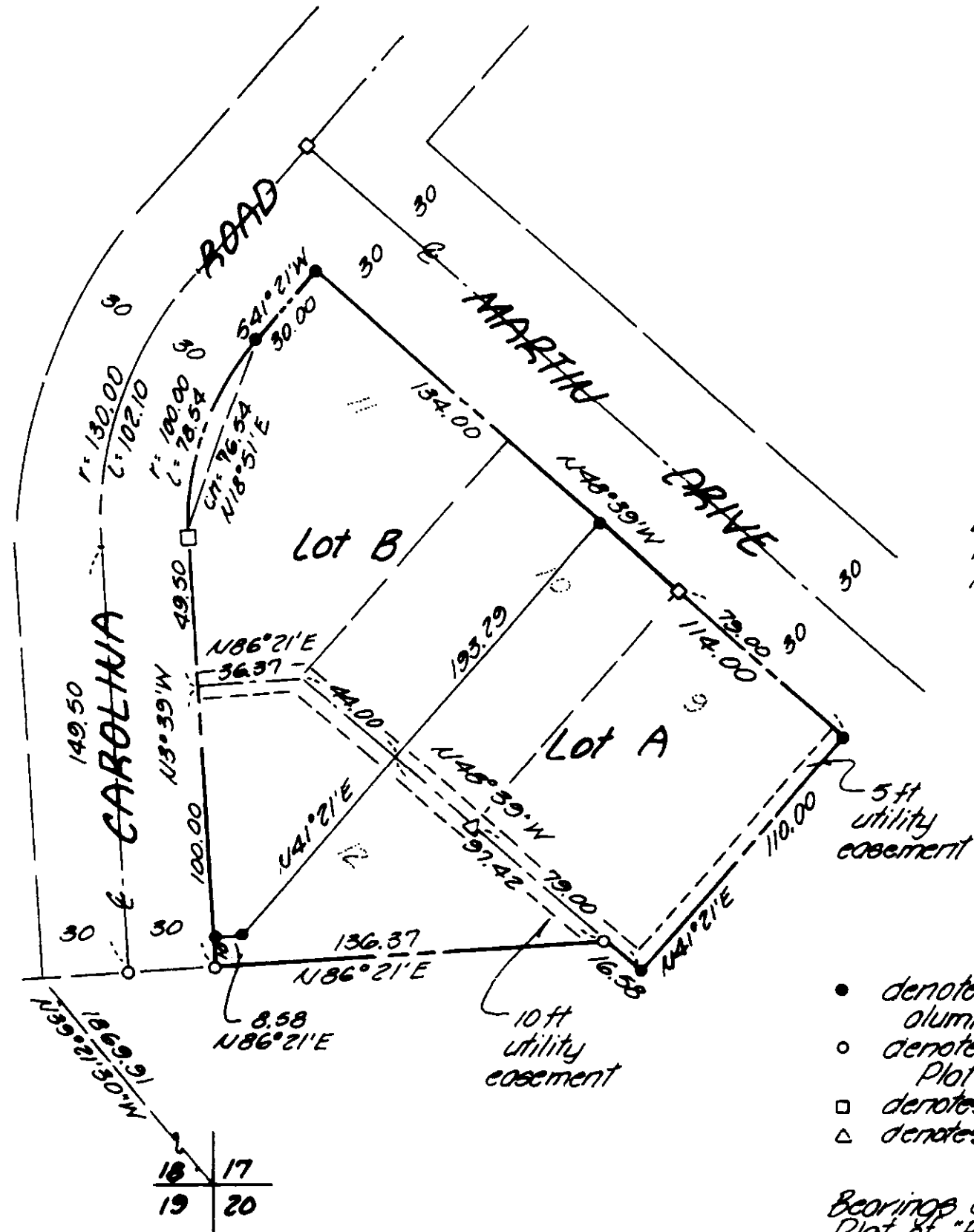


# REPLAT OF LOTS 9, 10, 11 & 12, BLK 2, PETERSON ADDITION

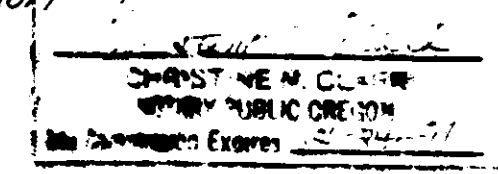

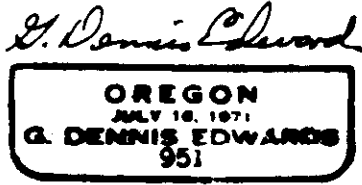
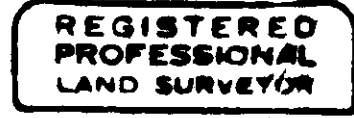
