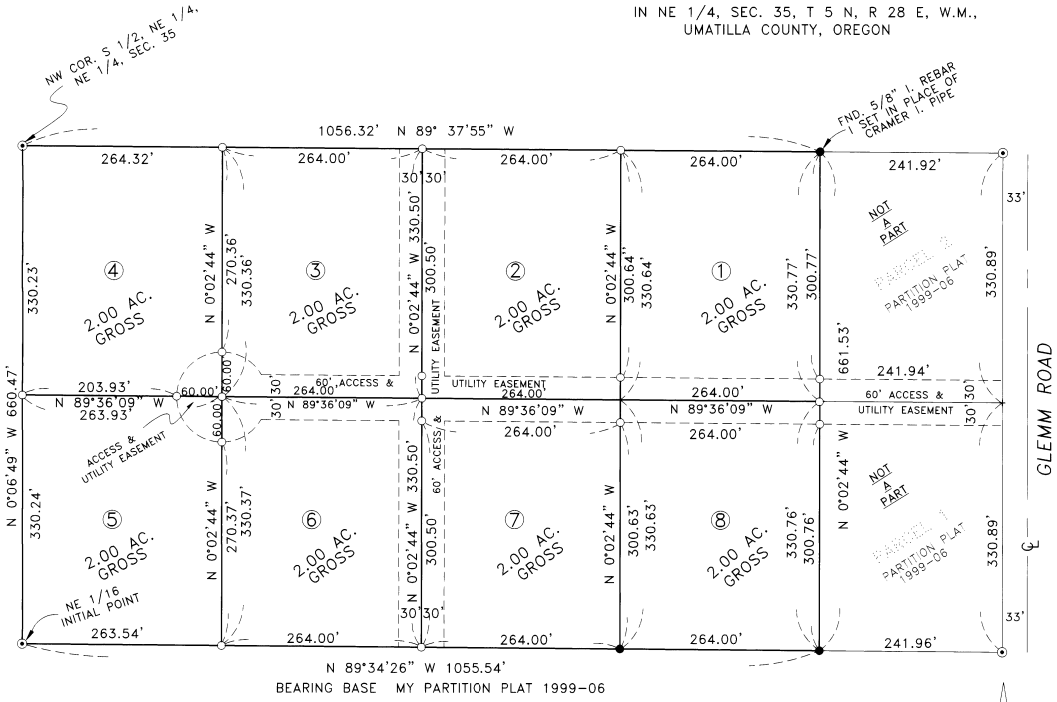


SHELLEY LYNN ESTATES

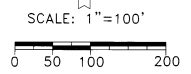
NARRATIVE:
 I, G. DENNIS EDWARDS, AM A REGISTERED LAND SURVEYOR OF THE STATE OF OREGON, AND HAVE MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THIS PLAT.
 THE INITIAL POINT IS A 1 1/4" IRON PIPE WHICH WALT CRAMER SET AT THE NE 1/16 CORNER IN A 1984 SURVEY FOR PETTEY.
 CRAMER SET 1" IRON PIPES AT ALL EXTERIOR LOT CORNERS IN A 1984 SURVEY FOR PETTY, MOST OF THEM WERE 0.3± OUT OF POSITION, SO I SET 5/8"x30" IRON REBAR AS SHOWN.

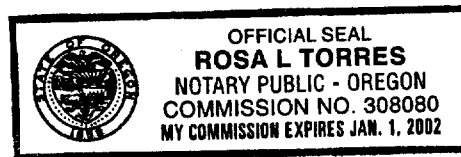
