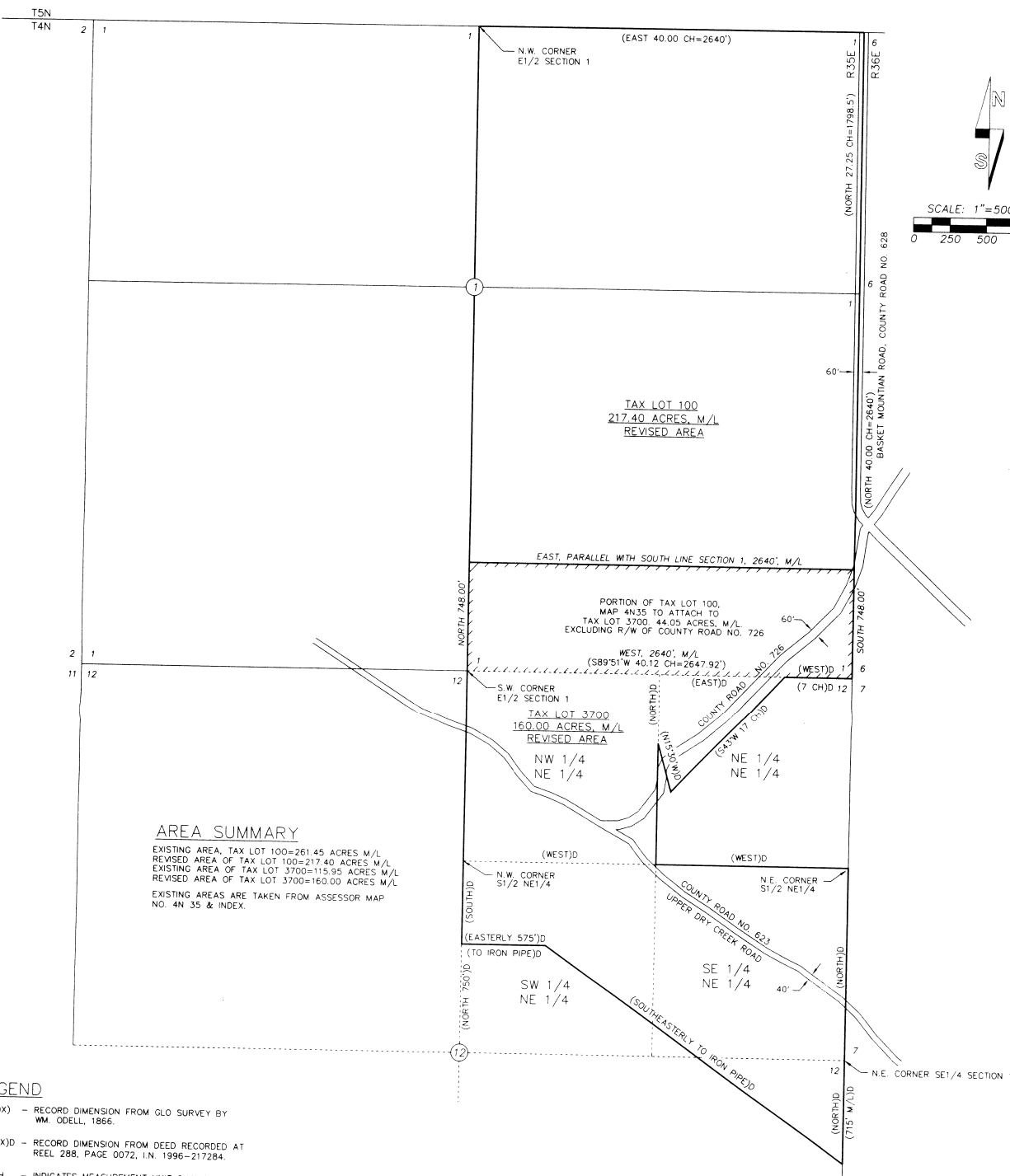


**BOUNDARY ADJUSTMENT MAP

BOUNDARY ADJUSTMENT DESCRIPTION:

PORTION OF TAX LOT 100, MAP 4N 35 TO ATTACH TO TAX LOT 3700, MAP 4N 35:
A tract of land located in the East Half of fractional Section 1, Township 4 North, Range 35 East, W.M., Umatilla County, Oregon, described as follows:
BEGINNING at the Southeast Corner of said Section 1; thence West along the South line of said Section 1 a distance of 2640 feet, more or less, to the Southwest Corner of said East Half, thence North along the West line of said East Half a distance of 748.00 feet; thence East, parallel with the South line of said East Half a distance of 2640 feet, more or less, to a point on the East line of said Section 1; thence South along the East line of said Section 1 a distance of 748.00 feet to the POINT OF BEGINNING.

NARRATIVE:

THIS MAP WAS DRAWN AT THE REQUEST OF DEBRA POPE FOR THE PURPOSE OF A BOUNDARY ADJUSTMENT OF TAX LOTS 100 AND 3700, TAX MAP 4N35. THE AREA OF TAX LOT 3700 IS TO BE INCREASED TO 160 ACRES, M/L.
