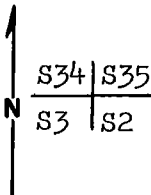

From where Rd. 3128 makes a sharp right turn about 1/2 mile from the West line of Sec. 36 go West to ridge top. Follow ridge top South 4000 ft. to fork. Follow fork West 1000 ft. to location tag on 14" Pine. Corner is N20W-900 ft.. Can also be reached by following first tributary East of N/S flowing fork of Camp Creek for 1/2 mile.
