CERTIFICATE OF REMONUMENTATION 26 APRIL 2017

Primm, do hereby depose and say that I am a registered professional land surveyor in the State of Oregon and that I have reestablished the following lot corners in the Southeast Quarter of Section 10, Township 4 North, Range 28, East of the Willamette Meridian, City of Hermiston, Umatilla County, Oregon.

I previously performed Town Centre Re-Plat in April of 2015, said Town Centre Re-Plat is recorded in Book 16, Page 19 as survey number 15-120-B.

The Northeast, Southwest and Northwest property corners of Town Centre Re-Plat have been destroyed during construction activities on the site. I was contracted through the client to remonument the above mentioned destroyed property corners during the final mapping procedures on the facility. The 3 property corners in the Southeast corner of the property were recovered.

The Northeast property corner was originally monumneted with a PK nail with a washer stamped "PLS LS 48509" during the Town Centre Re-Plat. I remonumented this property corner with a PK nail with a washer stamped "PLS LS 48509" in its original location as the Town Centre Re-Plat.

The Southwest property corner was originally monumneted with a PK nail with a washer stamped "PLS LS 48509" during the Town Centre Re-Plat. I remonumented this property corner with a 5/8 inch by 30 inch iron rod with a yellow plastic cap stamped "PLS LS 48509" in its original location as the Town Centre Re-Plat.

The Northeast property corner was originally monumneted with a 5/8 inch by 30 inch iron rod with a yellow plastic cap stamped "PLS LS 48509" during the Town Centre Re-Plat. I remonumented this property corner with a 5/8 inch by 30 inch iron rod with a yellow plastic cap stamped "PLS LS 48509" in its original location as the Town Centre Re-Plat.
