One Dollar paid them the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey into the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 100 feet wide, being 100 feet on each side of the center line of said road, as surveyed over and across

the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: In the W 1/2 of Section 34, T 1 N. R. 35 E 1/4 and the NW 1/4 of the NE 1/4 and the NE 1/4 of the NW 1/4, of section 3, T 1 S R 35 E 1/4. within a strip of land as hereinafter described:

A strip of land 100 feet wide, being 50 feet on each side of the center line of the Old Oregon Trail, as surveyed and staked across said property, said center line being more particularly described as follows: Beginning at a point on said center line survey designated as station 1516 / 00, said point being approximately 135 feet west and 1974 feet south of the section corner common to sections 27, 28, 33 and 34, T 1 N R 35 E 1/4; thence south 32 degrees 23' east a distance of 669.9 feet; thence on a 10 degree curve to the left a distance of 459 feet; thence south 78 degrees 16' east a distance of 471.9 feet; thence on an 20 degree curve to the right a distance of 284.4 feet; thence south 21 degrees 23' east a distance of 308.9 feet; thence on a 5 degree curve to the left a distance of 279.7 feet; thence south 35 degrees 23' east a distance of 125.4 feet; thence on a 9 degree curve to the right a distance of 207.8 feet; thence south 16 degrees 40' east a distance of 28.3 feet; thence on a 12 degree curve to the left a distance of 287.5 feet; thence south 51 degrees 10' east a distance of 93.6 feet; thence on a 7 degree curve to the right a distance of 451.9 feet; thence south 19 degrees 32' east a distance of 240.9 feet; thence on a 1 degree curve to the left a distance of 1061.7 feet; thence on a 3 degree curve to the left a distance of 368.8 feet; thence south 41 degrees 12' east a distance of approximately 23 feet to the intersection of said center line survey with the north boundary line of lot 6, block 1, in the platted townsite of Aetna.

Thence, a strip of land 60 feet wide, being 30 feet on each side of the said center line from a point where said center line intersects the north boundary line of said lot 6, which point is approximately 5 feet west of the NE corner of said lot 6; thence south 41 degrees 12' east a distance of approximately 68.9 feet; thence on a 16 degree curve to the right a distance of approximately 142 feet to a point where said center line intersects the east boundary line of lot 2 in block 1 in said platted townsite of Aetna, which point is approximately 24 feet south of the NE corner of said Lot 2, and is approximately 1933 feet west and 4461 feet north of the section corner common to sections 2, 3 10 and 11, T 1 S R 35 E 1/4. This parcel of land contains, 12.01 acres, more or less.
