

### In the Matter of Oregon Road

Known as the PENDLETON-COLD SPRINGS HIGHWAY

Know All Men by These Presents, That I, Holmgren and Kaet Holmgren, his wife,

of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of

paid to them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

A strip of land 60 feet wide, being 30 feet wide on each side of the center line of Pendleton-Cold Springs Highway as surveyed over and across a portion of Section 4, Township 2 North, Range 32 East, W.M. which center line is more particularly described as follows:

Beginning at a point on the south line of said Section 4, 17.5 feet North and 813.9 feet West of the Southeast corner of Section 4, thence North 19° 27' East, 83.8 feet, thence on a 1910 feet radius curve to the left, 266.7 feet, thence North 11° 27' East, 225.1 feet, thence on a 1910 feet radius curve to the right, 281.7 feet, thence North 19° 54' East, 1744.2 feet, thence on an 818.5 feet radius curve to the left, 136.5 feet to a point on the north line of the south half of said Section 4, which is 2.0 feet West of the Quarter Section corner on the East side of said Section 4. All in Township 2 North, Range 32 East, W. M. Also a tract of land described as follows: Beginning at a point 157 feet North of the Quarter Section corner on the East side of Section 4, Township 2 North, Range 32 East, W.M. thence North, following the Section line, 206.0 feet, thence West, 30 feet, thence South, running parallel to the East line of said Section 4, 206.0 feet, thence East, 30 feet, to the place of beginning. All in Section 4, Township 2 North, Range 32, East W. M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
