Known as the Pendleton-Cold Springs Highway

Know All Men by These Presents, That Herman Suhl and Edith A. Suhl, his wife

of the County of Wood River

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Five Dollar.

Five paid to them the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

A Strip of Land Sixty (60) feet wide being thirty (30) feet on each side the center line of the Pendleton-Cold Springs Highway and as more particularly described as follows,

Beginning at a point known and designated as Station 215+03.7 P. C. which point is eighty (80) feet north of the South East corner of Section 28 T. 4 N., R. 32 E. W. 1/4, running thence North 0°32' West, 00 feet, thence on a curve to the left of radius 477.5 feet, a distance of 293.1 feet, thence North 35°42' West 373.2 feet, thence on a curve to the left of radius 1432.5 feet, a distance of 377.1 feet, thence North 50°47' West 217.3 feet, thence on a curve to the left of radius 573.0 feet, a distance of 383.3 feet, thence North 89°07' West, 462 feet, thence on a curve to the right of radius 477.5 feet, a distance of 610.1 feet, thence North 27°54' West, 1317.1 feet to a point known and designated as Station 250+26.1 which point is 192 feet east of the center of Section 28 T. 4 N., R. 32 E. W. 1/4.

To Have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever. the grantee herein as part of the consideration, shall agree to build a three wide fence with cedar posts a rod apart on each side of the road described right of way and to construct a substantial stock pass under the above described roadway
