All that property of Jessie Franklin in the NW 1/4 of section 30 T 5 N R 31 EWM, within a strip of land 60 feet wide, being 30 feet on each side of the center line of the Pendleton Gold Spring Highway, as surveyed across said property, said center line survey being more particularly described as follows: Beginning at a point on said center line survey known and designated as station 530 + 21.6, said point being approximately 30 feet north and 96 feet west of the one quarter section corner common to sections 19 and 30 T 5 N R 31 EWM; thence on a 2 degree curve to the right a distance of 953.4 feet; thence south 39° 56' east a distance of 20.4 feet; thence on a 5 degree curve to the left a distance of 216.7 feet; thence south 50° 46' east a distance of 196.1 feet; thence on a 4 degree curve to the left a distance of 587.1 feet; thence on a 2 degree curve to the left a distance of 727.5 feet; thence on a 20 degree curve to the left a distance of 85.9 feet; thence on a 2 degree curve to the left a distance of 361.7 feet; thence N 66° 47' E a distance of 806.6 feet; to a point known and designated as station 564 + 77.0, said point being approximately 265 feet east and 940 feet south of the section corner common to sections 19- 20- 29 and 30, T 5 N R 31 EWM, said parcel of land containing 4.32 acres, more or less.
