Range 31 E.W.M. within a strip of land 60 feet wide, being 30 feet on each side of center line of the Pendleton, Cold Springs Highway, as surveyed across said property, said center line of survey being more particularly described as follows: Beginning at a point known and designated as station 699 + 59.6, said point being approximately 2298 feet south and 4393 feet east of the section corner common to sections 28-29-32 and 33, Twp. 5 N. Range 31 E.W.M; thence 74° 01' east a distance of 160.4 feet; thence on a 10 degree curve to the right a distance of 556.5 feet to a point known and designated as station 706 + 76.5, said point being approximately 2128 feet south and 5054 feet east of the section corner common to sections 28-29-32 and 33, Twp. 5 N.
