paid him, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across

the Southeast Quarter of the Southwest Quarter of Section 34 Township 5 North Range 31 East W. L. S. 46 deg. 26' E. to Station 741 / 55, a point on the said center line survey approximately 250.0 feet West of the N. E. Cor. S. E. 1/4 of the S. W. 1/4 sec. 34 T. 5 N. R. 31 E. W. L., thence S. 46 deg. 26' E. 340.8 feet, thence on a ten deg. curve to the right 109.2 feet to Station 745 / 05.0 a point on the said center line survey approximately 250.0 feet South of the N. E. Cor. of the S. E. 1/4 - S. W. 1/4 sec. 34 T. 5 N. R. 31 E. W. L., thence on a ten degree curve to the right, said parcel of land containing 0.48 acres more or less.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
