Know All Men by These Presents, That Howard C. Dunn and Edith Dunn, his wife,

of the County of Umatilla, in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar paid to them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across

The Southwest Quarter of the NorthWest Quarter ; of Section 27 Township 2 North Range 32 East W.M. Beginning at a point on the 1/4 section line between the NW 1/4 and the SW 1/4 of Section 27 T. 2N.R. 32 E.W.M which point is approximately 175.0 feet E of the 1/4 section corner between Sec. 27 and 28 T. 2 N.R. 32 E.W.M running thence N 4° 35' W, a distance of 42.2 feet; thence on a 1146.0 foot radius curve to the left a distance of 560.8 feet; to a point on the section line between sections 27 and 28, T. 2 N.R. 32 E.W.M which point is approximately 564 feet N of the 1/4 corner between section 27 and 28, T. 2 N.R. 32 E.W.M; said parcel, containing 0.83 acres more or less.

The above contains 0.80 acres within the right of way of the existing county road, and 0.03 acres to be acquired.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
