ORDER

WHEREAS, John and Eloise Kilby have made it known to the Board of Commissioners that they wish to donate two (2) parcels of land to the public for road purposes, and

WHEREAS, the parcels of land would widen a portion of the Old Theater Road right-of-way by approximately 41.5 feet and are described as follows:

Parcel A:

Beginning at the W $\frac{1}{4}$  Corner of Section 8, Township 2 North, Range 33 E.W.M.; thence S 89°52'20"E, 41.64 feet; thence S0°06'E, 595.34 feet; thence N 89°40'20"W, 41.98 feet; thence N 0°04'07"W, 595.34 feet to the point of beginning. This parcel contains 0.57 acres.

Parcel B:


Beginning at a point S0°04'07"E and 645.34 feet from the W $\frac{1}{4}$  corner of Section 8, Township 2 North, Range 33 E.W.M.; thence N 89°40'20"E, 41.99 feet; thence S0°06'E 709.47 feet; thence S 89°16'30"W, 42.38 feet; thence N 0°04'07"W, 709.47 to the point of beginning. This parcel contains 0.69 acres.

WHEREAS, the Public Works Director has inspected the parcels in question and has recommended that the Board of Commissioners accept them for public road purposes,


NOW, THEREFORE, IT IS ORDERED that the parcels of land described above be accepted for public road purposes and they are to be recorded in the County Records.



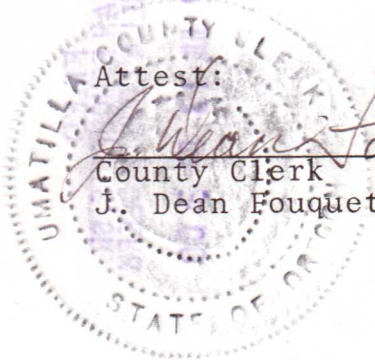
