DEED OF DEDICATION

KNOW ALL MEN BY THESE PRESENTS, That the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, as legal owner of the hereinafter described property, does hereby give, grant and dedicate unto the public, for public road purposes the following described property, to wit:

That certain real property consisting of 4 parts situated in Sections 16, 21, 26, 27 and 35, Township 2 North, Range 33 East, W.M. and in Section 8, Township 1 North, Range 34 East, W.M., Umatilla County, Oregon:

Part 1 being that portion of that property designated as Parcel 1 and described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 312, Page 442 of Umatilla County Record of Deeds lying Northwesterly of a line at right angles to the center line of the Westbound lane of the relocated Old Oregon Trail Highway at Engineer's Station "WB" 394+00 and Northeasterly of a line parallel with and 100 feet Northeasterly of said center line, which center line is described in said State of Oregon deed.

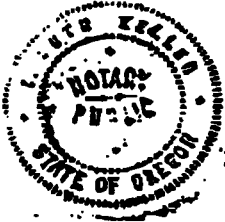
