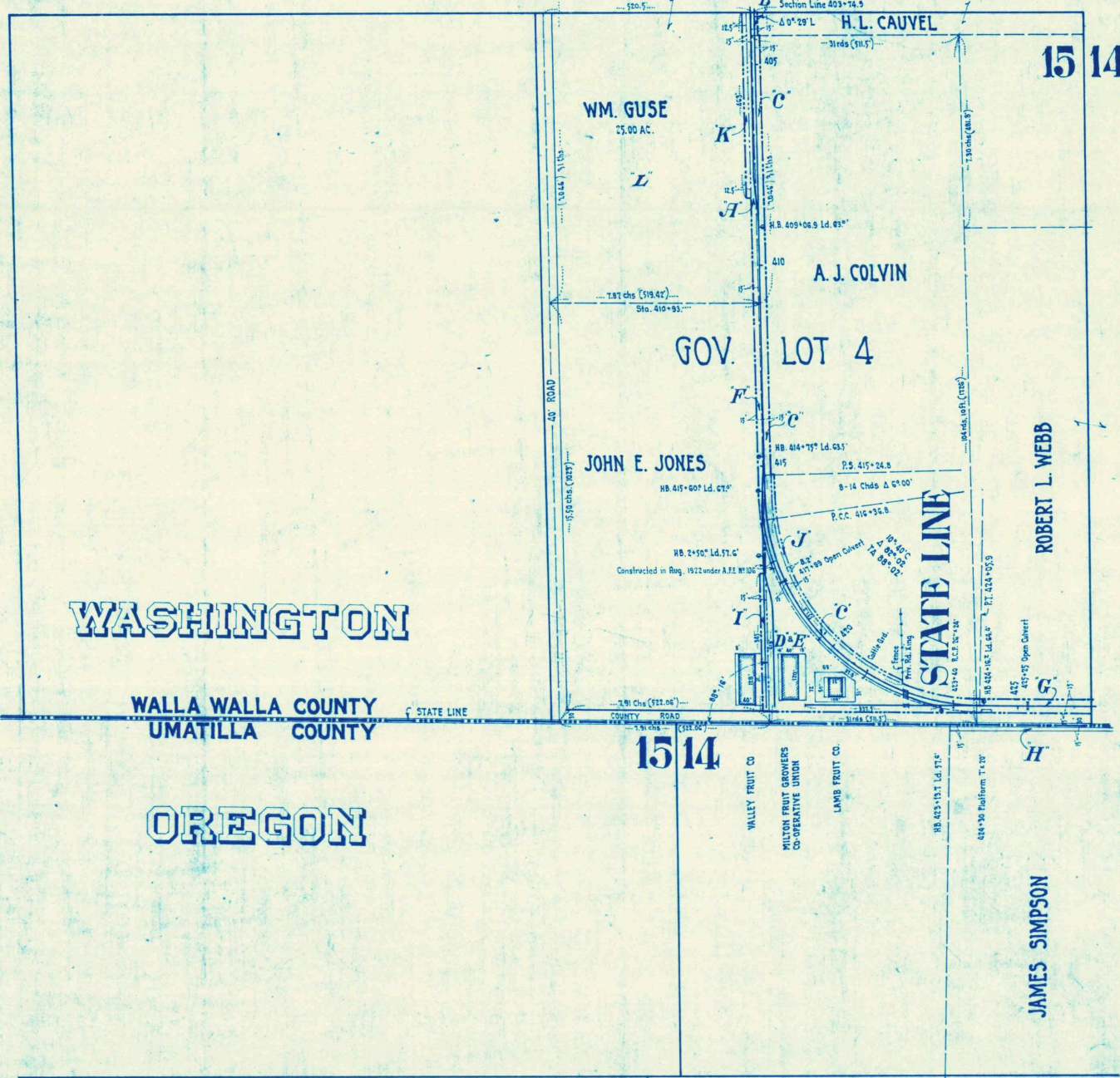
Main Line, Walla Walla to Milton *Right of Way Plat*
